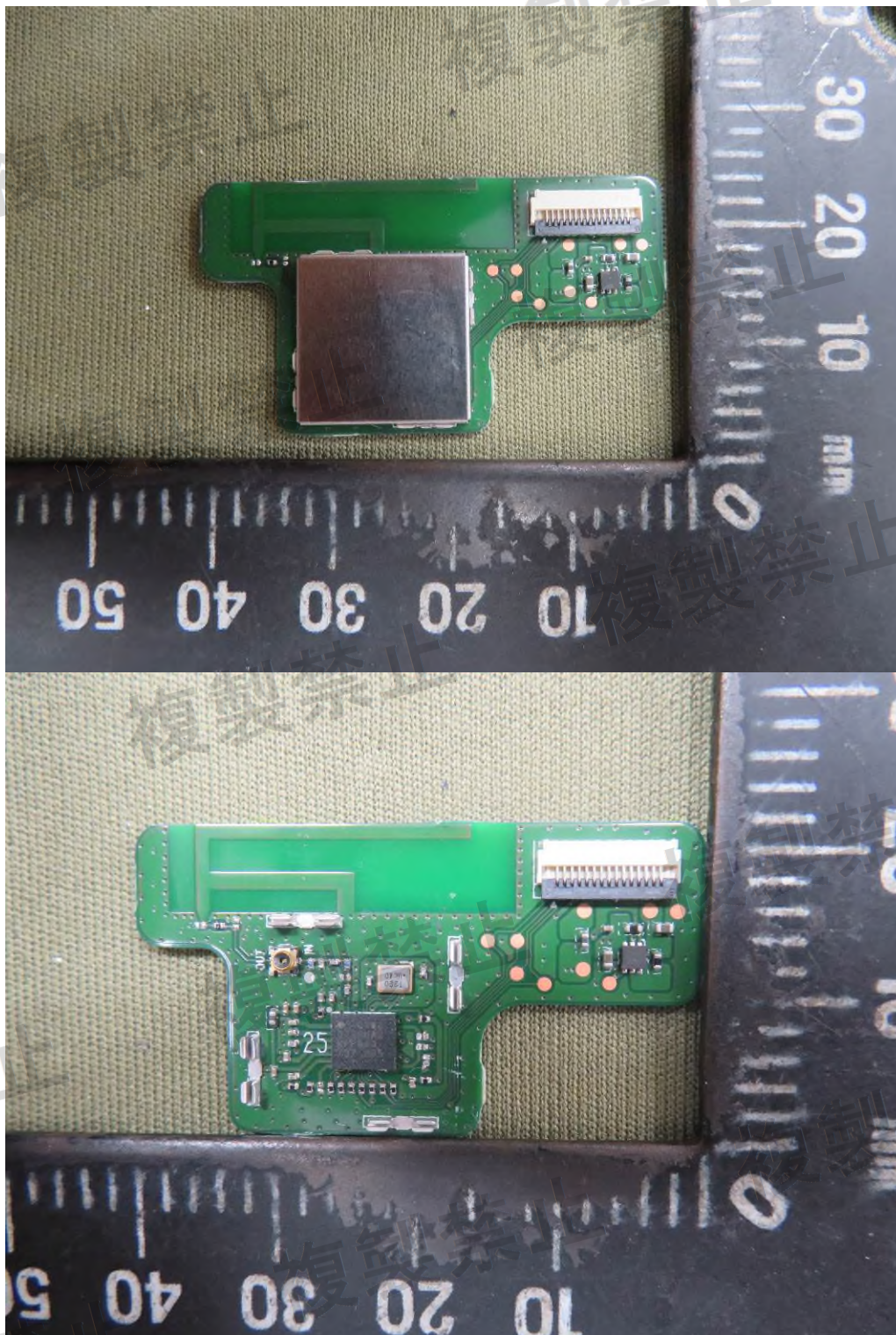





3 ABOUT UNCERTAINTY OF MEASURED VALUE

*In this test, the influence of an error or uncertainty may be done according to the following factors.

- Bias of a measurement equipment, Change by aging, Attrition, Noise
- Skill and capability of an inspector
- Environment (Temperature, Humidity)
- Dispersion in a EUT (Equipment Under Test)
