

## Chapter 2 Frequency Allocation Table

1. The explanations of the columns in the table are as follows.
  - (1) Columns 1 to 3 in the Table show, as a reference, the international frequency allocations stipulated in Article 5 of the RR.
  - (2) Column 4 in the Table shows national frequency allocations of Japan. Any conditions of radiocommunication services are indicated with parentheses. The upper limit frequency is included, but the lower limit frequency is not included in each frequency band.
  - (3) The radiocommunication services in the columns 1 to 4 in the Table are expressed with the following manner.
    - a. Services printed in “capitals” (e.g. FIXED) are called “primary” services, and services printed in “normal characters” (e.g. Mobile) are called “secondary” services.
    - b. Frequencies are assigned to radio stations of secondary services under the following conditions:
      - The use of the frequencies shall not cause harmful interference to stations of primary services to which frequencies are already assigned or to which frequencies may be assigned in the future.
      - The radio stations cannot claim protection from harmful interference from stations of primary services to which frequencies are already assigned or may be assigned in the future.
  - (4) Column 5 indicates the purposes of radio stations that frequencies may be assigned to.
  - (5) Column 6 indicates conditions for the use of frequency. Assigned frequencies shall follow the conditions in this column.
2. The order of radiocommunication services printed in a frequencies band does not indicate the relative order of priority.
3. The contents of footnotes in column 4 indicate conditions for frequency assignment.
4. In column 4, the footnotes printed at the bottom of each block are related to the whole frequency band; those following each radiocommunication service are related only to the corresponding service.
5. The purposes of radio stations of radiocommunication services, other than those prescribed in column 4 or the footnotes, shall follow the table below.

6. The order of the purposes of radio stations in a frequency band does not indicate the relative order of priority.
7. In columns 4 to 6, the blocks may be divided horizontally with dotted lines in order to make clear the correspondence among radiocommunication services, purposes of radio stations, and conditions for the use of frequency.
